- 1. Current enrollment is 1039 combined with 582 students K-4 and 457 students
- 2. PUC Goal Update: We will review all academic goals and data at the next board meeting along with the annual report/WBWF plan.
- 3. PUC Goal Update: We held parent teacher conferences on Tuesday 10-16 & Wednesday 10-17-18 -- we will have final conference data at the November board meeting as well.
- Preliminary baseline data for MAP Reading shows 46.9% of students meeting beginning of year expectations. Preliminary baseline data for MAP Math shows 47.3% of students meeting beginning of year expectations. Kindergarten Readiness data shows approx. 60% of Kindergartners were ready for school by mid-September based on our MAP data.
- 5. Teachers have been focusing on PLC work and essential literacy standards during their professional development times each week. We have 13 new staff members who are participating in New Teacher Seminar sessions once a month as well. EAs have bi-monthly training on ENVoY and classroom management.
- 6. We had a strong showing of support for national Unity Day (anti-bullying) on Wed. Oct. 24th with many students and staff wearing orange in support of being kind & standing up against bullying.
- 7. We are still working on putting the final items in place after the construction. We have furniture on order and items ready for install as soon as possible as well as a few more vendors coming out to complete new
