- 1. We are back to in-person learning this week! After much conversation with our transportation company, we have reached some working agreements which we believe will help in providing reliable transportation for our students during the bus driver shortage.
- 2. Enrollment is holding steady at 1071.
- 3. MCAs were taken for any student whose family chose for them to participate during the week of May 3rd and May 10th. Elementary had approx. 195 out of 241 students tested and Middle School had approx. 360 out of 476 students tested. Scores will not be used for district or school accountability this year but give us a data point to gage learning during the pandemic and a baseline of where to begin once school resumes, hopefully back to full in-person learning in the Fall. Unofficial scores for individual students will be sent to parents on Friday with official scores from the State expected later this summer
- 4. We are working on plans for Kdg and 8th grade graduation ceremonies in alignment with the safe learning plan and gathering guidance from MDE and MDH. These events will take place in June prior to the end of the school year.
- 5. We are currently posting and interviewing for available positions for next school year. Several open positions have already been filled.
